- The rig's mud tanks and solids processing system will be supplemented with additional solids processing equipment and related tanks to collect drill solids and liquids.
- Portable frac tanks will also be placed on the location for storing fresh water, brine water, and mud from the drilling operations to be re-used.
- Bins will be on location to temporarily store solids that will be trucked off to an approved disposal location,

Operating and Maintenance Plan:

- A walk around the tanks and cuttings bins to inspect for leaks will be completed daily.
- If any leaks are detected the OCD will be called immediately.
- In the process of drilling operations, fluids not to be re-used and drill solids will be hauled off to an approved disposal location.

Closure Plan:

- When the well is completed, trucks will haul off the remaining fluids and solids to an approved disposal location.
