I. Design Plan

Above-ground steel tanks will be used for the management of all workover fluids

II. Operations and Maintenance Plan

Ranger 40 Petroleum LLC will operate and maintain all above-ground steel tanks and bins in workover operations in a prudent manner to prevent any leaks/spills. Should a leak occur, the appropriate division office will be notified within 48 hours of the discovery and the leak will be addressed. During such an upset condition the source of a leak is located and addressed as soon as it is discovered. Free liquids will be removed and loose topsoil will be used to stabilize the leak. Any contaminated soil will either be bioremediated or excavated and taken to an OCD-approved disposal facility.

III. Closure Plan

All workover fluids will go to above-ground steel tanks and will be hauled by various trucking companies to an OCD-approved disposal facility.

- 1- 250 bbl steel reverse tank

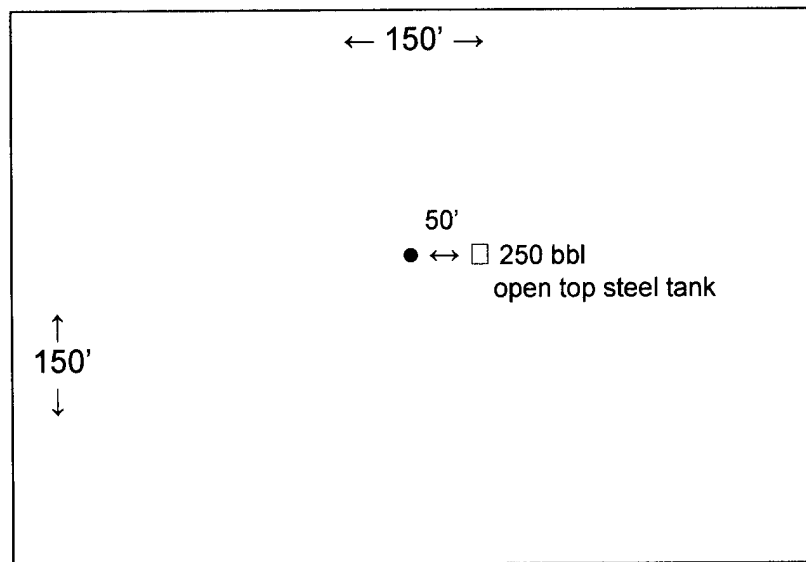
Operations and Maintenance
