Conditions of Approval

Three Rivers Operating Company – Pubco Fed. Com #1

1. Submit plan for approval of well operations within 30 days of this approval to change operator.

43 CFR 3162.3-4 (C) requires that wells incapable of production in paying quantities be promptly plugged and abandoned and requires approval for any well temporarily abandoned for more than 30 days.
2. Tank battery must be bermed/diked (must be able to contain 1 1/2 times the volume of the largest tank).
3. All above ground structures and equipment on the lease shall be painted Shale Green (5Y 4/2). This is to be done within 90 days, if you have not already done so.
4. Submit for approval of water disposal method.
5. Submit updated facility diagrams as per Onshore Order #3
6. This agency shall be notified of any spill or discharge as required by NTL-3A.
7. All outstanding environmental issue must be addressed within 90 days. Contact Jim Amos for inspection and to resolve environmental issues. 575-234-5909
8. Subject to like approval by NMOCD.
9. **The above mentioned well is in a Federal Communitization Agreement #NM71820 Submit for designation of successor operator for the CA. This well was also recompleted in the Strawn formation. Submit a completion report form 3160-4. Also need to expand the CA to include Strawn formation, submit request to expand the CA. Do all the above within 30 days of this approval**
