#### Design Plan, Operating & Maintenance Plan & Closure Plan

#### **DESIGN PLAN**

The Kochia AAM State Well No. 1 will be cleaned out to total depth, sidetracked, and deepened to a total depth of 14,500°. Drill cuttings and drilling fluid will run through a shale shaker where they will be separated. Drill cuttings will be stored in a haul-off bin that will be transported to either Sundance or CRI. Drilling fluid will be re-circulated to the steel tanks. Equipment to be utilized on location includes:

Shale Shaker
1 Mud Pump
1-500 bbl steel tank (Fresh water supply)
1-180 bbl steel working pit
2-75 bbls steel haul-off bins

#### **OPERATION & MAINTENANCE**

All components of the drilling system will be continually monitored and visually inspected at frequent intervals to assure proper operation. Any component malfunction will result in suspension of drilling operations until the problem can be repaired. Any leaks or discharges will be cleaned up and reported to the NMOCD.

#### Closure Plan

Upon completion of drilling and completion operations, the haul-off bins will be transported to either Sundance, Inc. or to CRI. Both sites are authorized by NMOCD to accept drill cuttings and associated drilling waste.
