Chevron U.S.A., Inc. requests administrative approval to amend PLC-59-B to allow for the surface commingling of oil and water production from the L.E. Grizzell Lease and the C.P. Falby A & B Federal leases in the existing Falby A & B Commingled Battery. PLC-59-B granted authority to commingle production from the C. P. Falby A & B Federal leases, which consists of Penrose Skelly (Grayburg) (Oil - 50350) Pool, Eunice San Andres; SW (Oil - 24180) Pool, and Cary San Andres Gas (Gas - 96801) Pool production. The surface commingling of the L. E. Grizzell lease will add production from the Drinkard (Oil - 19190) and Paddock (Oil - 49210) Pools. The proposed new C. P. Falby wells, to be drilled later in 2011, will add Blimbry Oil & Gas (Oil - 6660) Pool production. Approval is requested to amend PLC-59-B to grant authority for the surface commingling of these additional pools into the existing C. P. Falby A & B Commingled Battery. Chevron is the operator with 100% working interest, in all three leases. The royalty interest owners are different, therefore notification was sent to the royalty owners, (list included with the attachments). Current plans are to produce the Grizzell wells into a 3-phase separator with meters for oil, water, and gas, in accordance with applicable provisions of the NMOCD's "Manual for the installation and Operation of Commingling Facilities, located on the L. E. Grizzell lease. The Grizzell gas will also be sold at this site. The Grizzell oil and water will be measured and then pumped to the C. P. Falby A & B Commingled Battery for processing. This commingling is necessary because the existing L. E. Grizzell Battery is in poor condition and the wells are too marginal to justify a battery upgrade. The nearby C. P. Falby A & B Commingled Battery can easily handle the fluid production from the L. E. Grizzell lease. The fluids to be commingled are compatible, and as shown on the attached table, the sales value of the crude oil will not be significantly affected.

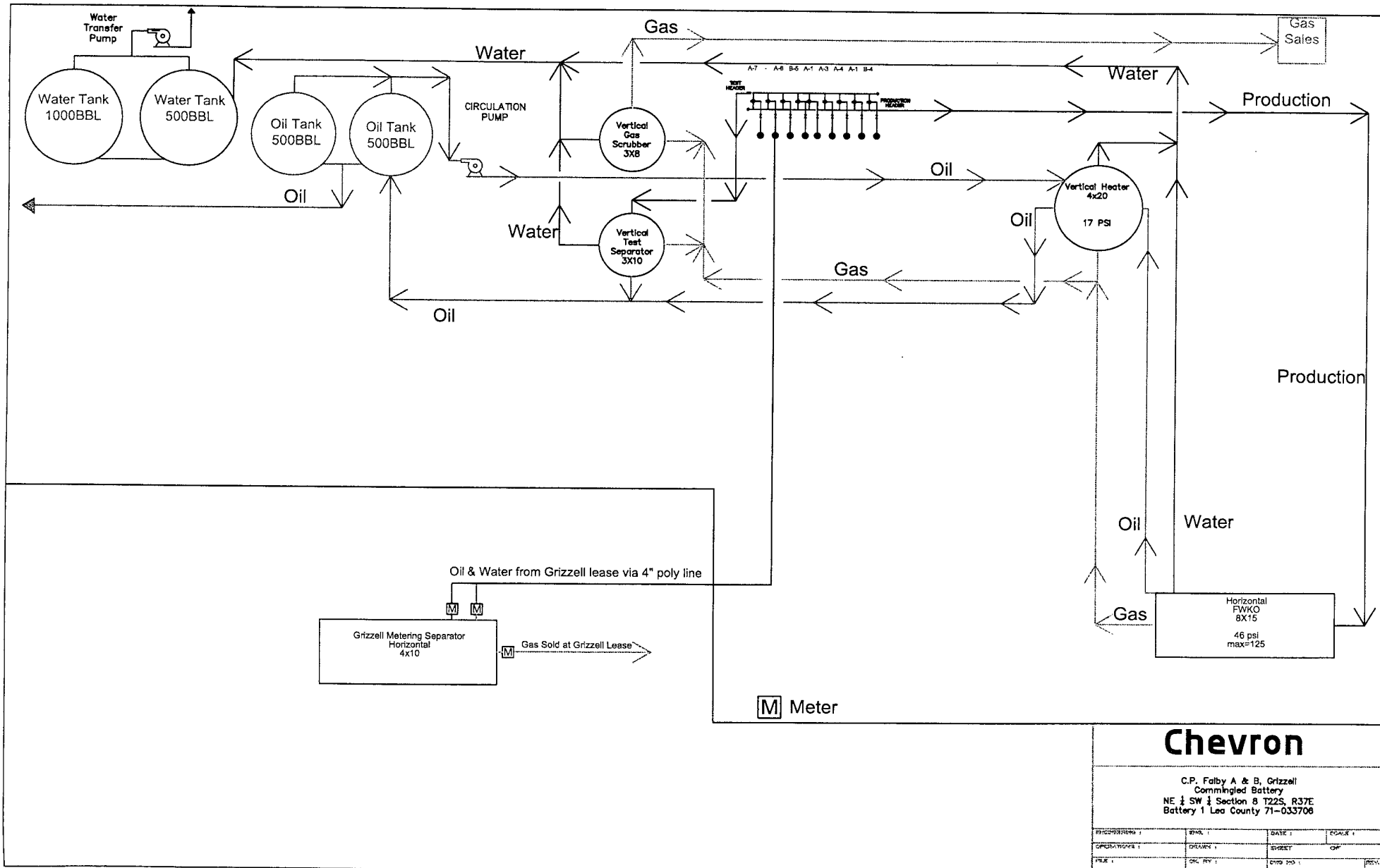
