Subsequent Report of Adding Additional Perforations to 2nd Bone Spring Sand and Refracking 2nd Bone Spring Sand Interval: On Nov. 10, 2010 McElvain O&G added additional perforations to the existing 2nd Bone Spring sand formation. The added perfs, shot at 2 spf & 120 degree phasing were from 9,560 - 9,572 and 9,532 - 9,542'. With the addition of these new perforations, the gross perforated interval in the 2nd Bone Spring amounted to 66' from 9,532 to 9,598' (34' net, 92 holes). On Nov. 13, 2010 the 2nd Bone Spring was ReFracked by BJ Services w/2000 # 20/40 sand, 12,000 # LiteProp 108 and 8,660 # of 20/40 SLC in 4,527 bbls of slick water.
