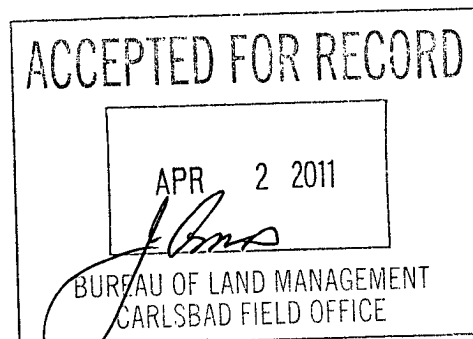
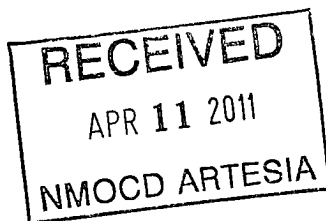

3/12/11 Tested casing to 1400 psi for 30 minutes. Test good.
Resumed drilling 11" hole.
