#### Closed-Loop Design Plan:

The closed loop system will not entail a drying pad, temporary pit, below grade tank or sump. It will entail an above ground haul-off bin suitable for holding the cuttings and fluids for rig operations. The haul-off bin will be of sufficient volume to maintain a safe free board between disposal of the liquids and solids from rig operations.

- 1.) Fencing is not required for an above ground closed-loop system.
- 2.) This site will be signed in compliance with 19.15.3.103 NMAC.
- 3.) Please see attached Closed-Loop System diagram.

## Closed-Loop Operating and Maintenance Plan:

In order to protect public health and environment, the closed-loop haul-off bin will be operated and maintained to contain liquids and solids. This will aid in the prevention of contamination of fresh water sources. To attain this goal the following steps will be followed:

- The sollds and liquids in the closed-loop haul-off bin will be transported off the drilling facility and disposed of at the CRI facility (Permit No. R9166) in Halfway, NM on a periodic basis once a bin is determined to be at full volume capacity.
- No hazardous waste, miscellaneous solid waste or debris will be discharged into or stored in the tank. Only fluids or cuttings used or generated by rig operations will be placed or stored in the tank.
- The division district office will be notified within 48 hours of the discovery of compromised
  integrity of the haut-off bin. Upon the discovery of the compromised haut-off bin, repairs
  will be enacted immediately.
- All of the above operations will be inspected and a log will be signed and dated. During
  dg operations, the inspection will be delly.

#### Closed-Loop Closure Plan:

The hual-off bin will be maintained in accordance with 19.15.17.13 NMAC. This will be done by transporting and disposing all cultings and liquids to the CRI Facility (Permit No. R8166) during and immediately following rig operations. The haul-off bins will be removed from the location as part of the rig move. At the time of well abandonment, the site will be reclaimed and re-vegetated to pre-existing conditions when possible.
