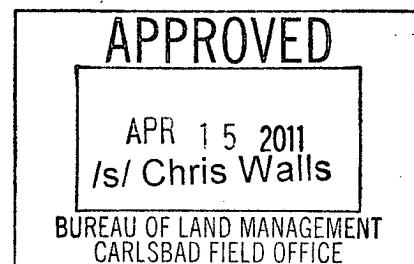

The pilot hole will be plugged from the pilot hole TD to KOP (7,864') with 2,300 sx Class H, 18.0 ppg, 0.90 cf/sk cement. An openhole whipstock will be set at KOP. Actual cement volumes will be adjusted based on caliper log results.
