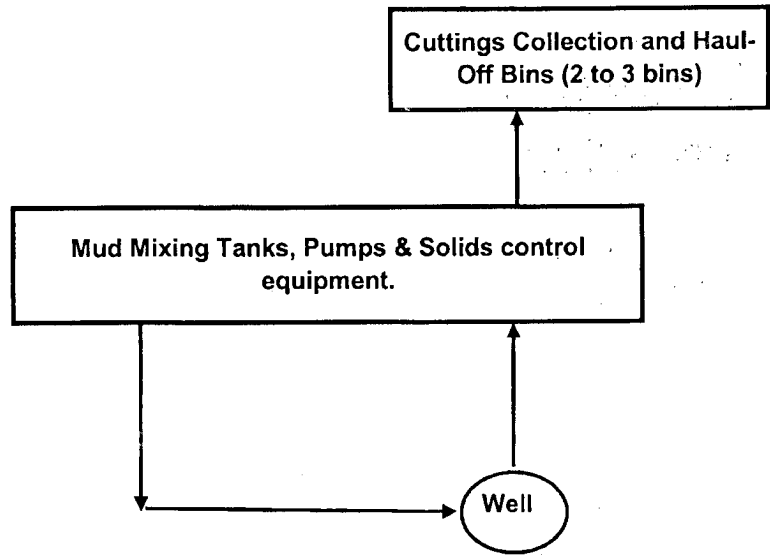

## **Design Plan:**



## **Operating and Maintenance Plan:**

During plugging operations, a third party service companies will utilize solids control equipment to remove cuttings from the drilling fluid and collect it in haul-off bins. Equipment will be closely monitored during operations by service company employees.

## **Closure Plan:**

During plugging operations, a third party service companies will haul off drill solids and fluids to the nearest approved disposal facility, as noted on the C-144 CLEZ form. At the end of the well, all closed loop equipment will be removed from the location.
