CHEVRON U.S.A. INC. INTENDS TO EXTEND THE TA STATUS OF THE SUBJECT WELL FOR AN ADDITIONAL YEAR DUE TO CURRENT DEVELOPMENT PLANS FOR THE UNIT.

THREE WELLS WERE DRILLED IN 2010 AND PLANS TO EXPAND THE DRILLING PROJECT ARE CURRENTLY UNDERWAY. IN ADDITION, SEVERAL WELLS WERE SAND FRACTURED STIMULATED IN THE PAST 2 YEARS, AND 5 MORE WILL BE STIMULATED THIS YEAR. SO FAR, DRILLING AND STIMULATION EFFORTS HAVE PROVEN SUCCESSFUL BUT REQUIRE FURTHER MONITORING. DEPENDING ON RESULTS OBTAINED, CHEVRON WILL ELECT TO EITHER REACTIVATE OR P&A THE WELLBORE.
