Yates Petroleum Corporation proposes to drill/test the Mississippian/intermediate formations. Approximately 400' of surface casing will be set/cemented. Intermediate casing will be set @ 4200', cement circ. to surface. If commercial, production casing will be run/cemented, perforate/stimulate as needed for production. MUD PROGRAM: 0-400' FW/Spud Mud; 400'-1900' FW; 1900' – 4200' Red Bed Mud/Oil; 4200' -7650' Cut Brine; 7650'- 9700' S Gel/Oil; 9700'- 11500' S Gel/Starch; 11500' to TD-SW/Starch/4%KCL. BOPE PROGRAM: A 5000 # BOPE will be installed on the 9 5/8" casing and tested daily.

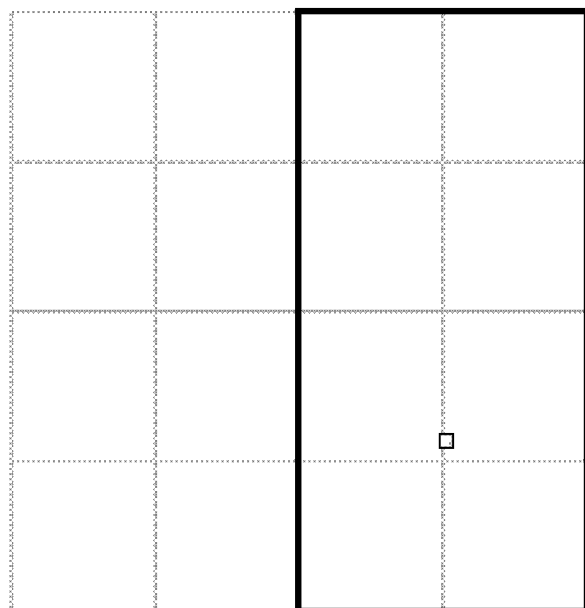
