## FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS) Abandon and plug as a dry hole. 330 feet of 10-3/4" surface pipe has been comented in the hole to protect the fresh water sands. None of this pipe will be pulled. A cement plug consisting of 30 sacks of cement will be set from 300 feet depth to 360 feet depth. A concrete slab 4 feet x 4 feet x 6 inches will be run in cellar to cover surface, in which a 4 inch iron pipe marker will be set. This marker will be allowed to project 4 feet above the mean ground level. Areas above and below the cement plug and up to the concrete slab will be filled with mud-laden fluid. No oil or gas encountered in this well. Offset lesses were held by ourselves under an escrew agreement.
