DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

11,177' Total Depth. Dolomite. Finished drilling 7-7/8" hole @ 5:00 AM on 4-30-55. Ran Schlumberger surveys. Ran a total of 279 joints of 5-1/2" OD casing set @ 11,177' and cemented with 900 sacks cement. Plug down to 11,090' @ 5:30 AM on 5-4-55. Maximum pump pressure of 2200#. Ran temperature survey and found top of cement outside of 5-1/2" OD casing @ 7927' or 48.9% fill. After W.O.C. for 24 hours tested 5-1/2" OD casing with 1200# pressure for 1/2 hour - no pressure drop. Drilled cement from 11,090' to 11,155' and tested casing with 1200# pressure for 1/2 hour - no pressure drop. Continued with completion operations.
