3522' Total depth, Lins. Finished drilling 11" hole @ 12:45PM, 12-24-55.
Ran total of 87 jts 8-5/8" CD Casing set @ 3522' and cemented with 1500
sx. cement. Pumped plug to 3134' @ 12:00midnite with 1200# press.
Ran temperature survey and found top of cement @ 735' or 50.9% fill.
After W.O.C. for 12 hours tested 8-5/8" casing with 1000# for 1/2 hour
- no pressure drop. Drilled cement from 3134' to 3522' and tested 8-5/8"
casing with 1000# for 1/2 hour - no pressure drop. Started drilling
7-7/8" hole @ 4:00PM, 12-26-55.
