1. Ran free point & cut 2 7/8" casing at 7630'
2. Spotted 30 sx. cement plug thru 2 7/8" casing at 7630'
3. Spotted 30 sx. cement plug thru 2 7/8" casing at 6155'
4. Spotted 20 sx. cement plug thru 2 7/8" casing at 4720'
5. Set McCullough open hole bridge plug at 4295' & dumped 5 sx. cement
6. Ran IGAC Amplitude-Acoustic-Gamma Ray-Caliper log from 3505' to 4275'
7. Set 5 1/2", J-55, 14 1/2" liner from 3434' to 4232' & cemented with 250 sx. Incor Pozmix 2% gel + 18% salt.
8. Perforated with 2 jets per foot from 4120' to 4128.
9. Acidized with 1000 gallons gelled acid.
10. Swabbed tested 4-5 bbls. oil per hour; no water.
11. Placed on pump.
