1. Move in and rig up contract unit.
2. Pulled rods and tubing.
3. Set Cast Iron bridge plug at 9700. Dumped one bailer full of cement on top of plug.
4. Perf Penn zone from 9066-9077 and 9088-9096 with one shot per ft. (PGAC)
5. Ran tubing with packer. Set packer at 9018.
6. Acidized perf 9066-77 and 9088-96 with 10,000 gallons 15% N.E. acid with an average injection rate of 1.8 BPM. Max pressure 3750# tubing. Job by Cardinal Chemical. Had & communications between csg and tbq, pulled tubing and packer. Found split joint. Replaced joint and reran tbq with packer. Set packer at 8981. Swabbed well.
7. Well flowed
8. Well recompleted in Penn zone as a flowing oil well.
9. Successful.
