Squeezed top of 5 $\frac{1}{2}$ " liner at 4313 with 200 sacks 4% gel and 200 sacks neat, 3000# pressure, Rev. out 30 sacks, W.O.C. 48 hours.

Tested top of 5 $\frac{1}{2}$ " liner with 2000# for 30 minutes - No break.
