DRILL STEM TESTS

- DST #1 - From 8200' to 8410' - 4 hrs. test - Opened tool w/good blow of Air - Gas up in 9 Min. - At end of test Gas Vol. 140,000 Cu. ft. p/d - No fluid to surface.  
Recovered: 7750' Gas in DP. 450' Drlg Mud cut w/an est. of 50% Gas.
- DST #2 - From 8400' to 8555' - 7 hrs. & 13 Min. test - Opened tool w/fair blow of Air - Gas up in 46 Min. Drlg. Mud & Salt Water up in 2 hrs. & 53 Min. - Flowed to Pits for 20 Min. then turned to tank - Flowed 2.53 bbls of Oil & 28.21 bbls of Salt Water in 4 hrs. Gas Vol. 286,070 Cu. ft. p/d.  
Recovered: 70' Fluid 1st. 50% Oil & 50% Salt Water. 1500' Salt Water Cut an est. of 5% ——— 500' Salt Water. Could Not get enough Oil to let Grav.
- DST #3 - From 9145 to 9257' - 4 hrs. test - Opened tool w/strong blow of Air - Gas up in 6 Min. Gas Vol. first hr. 590,990 Cu. ft. p/d. At end of 2nd hr. 750,000 Cu. ft. p/d & held throughout test. Had slight mist of mud up in 2 hrs. & 6 Min. No fluid to surface.  
Recovered: 1824' Distillate (Dark Amber). 370' Mud est. 20% Distillate mud Grav. 54.8 Corrected.
- DST #4 - From 10185' to 10290' - 4 hrs. test - Used 950' Water blanket. Opened tool w/good blow of Air Increased to heavy blow in 10 Min. Gas up in 17 Min. Gas Vol. 156,800 Cu. ft. p/d. & remained Steady for duration of test. No fluid to surface.  
Recovered: 950' Water blanket - 674' lightly gas cut Drlg. Mud. 561' Heavily gas cut Drlg. mud w/trace of Oil. No show of water
