DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

305' - Total Depth. - Red Bed. Finished drilling 17-1/4" hole @ 9:30 PM, 3/31/53. Ran a total of 7 joints (280') of 13-3/8" OD casing set @ 299' and cemented with 175 sk Pozmix "8" and 50 sk Incor cement. Total of 225 sk. Plug to 285' @ 1:30 AM, 3/31/53. Max. Pump Press. - 175# Cement circulated. After WOC for 12 hours - tested casing with 300# pressure for 1/2 hour - no pressure drop. Drilled cement from 285' to 305' - tested casing 300# for 1/2 hour - no pressure drop. Started drilling 12-1/4" hole @ 5:00 PM on 4/1/53.
