DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

10,715' Total Depth. Line. Finished drilling 7-7/8" hole @ 1:14 PM on 8/31/53. Ran drill stem test from 10,700' to 10,715' - four hour test - no gas or fluid to surface. Recovered 1605' of water blanket and 2598' of salt and sulphur water. No show of oil or gas. Prepared to plug and abandon. Hole was filled with heavy drilling mud. Spotted a 35 sack cement plug from 10,601' to 10,715 and a 35 sack cement plug from 8300' to 8414'; a 35 sack cement plug from 3455' to 3572'. Ran Dia-log casing cutter and cut off 8-5/8" OD casing @ 1038'. Salvaged 1045' of 8-5/8" OD casing. Filled hole with drilling mud and spotted 10 sack cement plug from 298' to 308' and a 10 sack cement plug in top of 13-3/8" OD casing from 0 to 10'. A piece of 4" line pipe was cemented in top of 13-3/8" OD casing and extends five feet above ground level to serve as a marker. Well plugged and abandoned on September 2, 1953.
