4405 4410 Gray to buff dense limestone

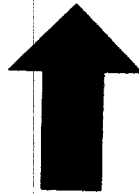
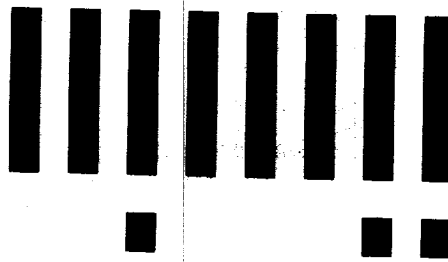

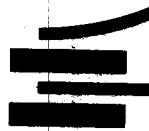
