3434' - Total Depth - Line - Finished drilling 11" hole @ 3:15 AM, 10/1/52 - Ran Schumber's Electrical, and Gamma Ray Surveys. Ran a total of 82 Jts of 8-5/8" casing set @ 3434' w/1500 Sx Cement. Plug pumped to 3349' at 11 PM, 10/1/52. Max pressure 1200#. Cement Circulated. After W.O.C for 24 hours, tested 8-5/8" casing w/1000# for 1/2 hour - no pressure drop. Drilled cement from 3349' to 3434' and tested casing with 1000# for 1/2 hour - no pressure drop. Started drilling formation and 6-3/4" hole @ 11:30 AM, 10/3/52 -
