DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 10 joints 316' of 13-3/8" OD 48# H-40 SS Casing. Set and cemented at 333' w/350 sacks regular Lone Star Neat cement, plug at 315'. Maximum pressure 200#. Cement circulated.

After waiting over 24 hours tested 13-3/8" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 315' to 333', tested cement below casing shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
