1. Set cast iron drillable cement retainer at approximately 10,400'.
2. Squeeze perforations from 10,436' to 10,588' with 100 sacks regular neat cement.
3. Perforate 5-1/2 inch casing from 10,190' to 10,202' with 2 jet shots per foot.
4. Acidize with 1000 gallons 15% LST-NE Acid.
5. Swab acid residue, test, and return well to production.
