Plan to set cast-iron bridge plug at 10,378' to plug off Devonian perforations at 10,408' to 10,428' and use Hydromite to plug back to 10,367: Re-perforate Devonian zone from 10,302' to 10,310', acidize and swab to flow. This remedial work to be performed in an attempt to reduce water production.
