## TD - 10,807\* PBTD 9890\* 52" casing set at 10,325'.

This well is presently shut-in as a gas well. In order to obtain commercial oil production, we desire to plug back and recomplete in the Queen formation in the following manner:

- 1. Squeeze casing perforations from 9736'-9840' with 150 sacks of cement.
- 2. Run free-point indicator on 52" casing, cut-off and pull salvageable casing.
- 3, Spot 30 sack cement plug in top of cut-off casing, 30 sack cement plug across exposed formation tops in open hole and 30 sack cement plug in bottom of 8 5/8" casing.

- 4. Set b. dging plug in 8 5/8" casin, at approximately 2950" and dump two sacks of Calseal on top of plug.
- 5. Jet perforate 8 5/8" casing from 2900' to 2930' and wash perforations with 500 gals. of mud acid.
- 6. Fracture perforations with 6000 gals. of lease oil carrying one pound of sand per gallon down tubingcasing annulus. Surface treating pressure not to exceed 2700 PSI.
