3610' - Total Depth - Line. Finished drilling 11" hole @ 2:15 AM, 12/18/52 - Ran 89 Jts of 8-5/8" OD casing set @ 3610' w/1500 sack cement. Pumped Plug to 3522'. Max Pressure, 1100#. Cement Circulated. After WOC for 24 hours - tested casing for 1/2 hour with 1000# - Drilled cement from 3522' to 3610' and tested casing for 1/2 hour with 1000# - no pressure drop. Started drilling formation and 7-7/8" hole @ 8 PM, 12/21/52 -
