**DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED**

Ran 11,126' of 5 $\frac{1}{2}$ " casing and cemented at 11,141' with 370 sacks of  $\frac{1}{4}$  gel and 300 sacks of neat cement. After WOC 14 hours ran temperature survey and found top of cement at 2210'. After WOC 60 hours determined freeze point by stretch test at approximately 4000'. After WOC 72 hours tested casing and cement with 1500 psi for 30 minutes before and after drilling plug. Test OK.
