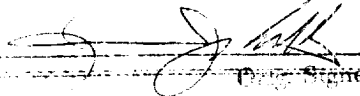

Re-entered on May 11, 1977. Clean out to 11,000'. Ran 4100' of 5½" 17# K casing and tied on to old 5½" casing. Perforate Penn zone 9100-10,600'. Acidized with 14,000 gal and swab tested. Swabbed 25 bbls water per day, tested non-commercial. On June 27, 1977 set bridge plug @ 4950 and dumped 2 sx cmt on top. Perf 4190-4210 (San Andres). Had communications. Perf 4250' and squeezed w/175 sx cmt. Acidize perfs 4190-4210 w/5000 gal 15% acid. Swabbed 15 bbls oil and 10 bbls water. Will test on pump.
