30 sacks from 11,477' to 11,377'

30 sacks from 10,808' to 10,708'

30 sacks from 10,232' to 10,132'

30 sacks from 8,497' to 8,397'

30 sacks from 7,307' to 7,207'

30 sacks from 6,520' to 6,420'

30 sacks from 5,054' to 4,954'

30 sacks from 3,710' to 3,610'

10 sacks in top of casing and erected usual marker.
