We propose to place 25 sax plug at 2990' (Top of Queen); 25 sax plug at 1460' (Shoe joint of 8 5/8" casing); entire hole filled with red bed mud.

We plan to pull and recover as much of 8" casing as possible, then place a 25 sax plug at 300' and a 10 sax plug at surface with marker.

Pits will be leveled and location cleaned up.

No fluid of any kind was encountered in drilling well
