3615' - Total Depth - Line. Ran Temperature Survey - Top of cement outside of ~~XXXXXX~~ 8-5/8" csg. @ 642'. Ratio of actual to calculated fill, 63.6%. Checked top of cement inside 8-5/8" csg. at 3534' and tested casing w/1000# for 1/2 hour - no pressure drop. Drilled cement from 3534' to 3615' and tested casing for 1/2 hour with 1000# - no pressure drop. Started drilling 7-7/8" hole at 4:30 AM, 5/24/52.
