DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3655' Total Depth. Lime. Finished drilling 11" hole @ 2:15 AM, 5/2/53. Ran a total of 100 joints of 8-5/8" OD casing set @ 3655' and cemented with 1500 sacks. Plug pumped to 3579' @ 2:45 PM, 4/2/53. Maximum Pump pressure - 1100#. Cement did not circulate. Ran temperature survey - top of cement outside of 8-5/8" casing @ 1017' or 51.1% fill. After WOC for 24 hours tested 8-5/8" OD casing with 1000# for 1/2 hour - no pressure drop. Drilled cement from 3579' to 3655'. Tested 8-5/8" OD casing with 1000# for 1/2 hr - no pressure drop. Started drilling 7-7/8" hole @ 3655' @ 11:40 AM on 5/4/53.
