DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

305' Total Depth. Red Bed. Finished drilling 12-1/4" hole to 305' @ 2:30 PM, 4/25/53. Ran a total of 7 jts (285') of 13-3/8" OD casing set @ 277' and cemented with 225 sacks cement. Plug pumped to 285' at 8:30 PM, 4/25/53. Maximum pressure - 200#. Cement circulated. After WOC for 12 hours, tested 13-3/8" OD casing with 300# for 1/2 hour - no pressure drop. Drilled cement from 285' to 305' - tested 13-3/8" OD casing with 300# for 1/2 hour - no pressure drop. Started drilling 12-1/4" hole @ 11:30 PM, 4/26/53.
