DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3038' Total Depth. Sand. Finished drilling 7-7/8" hole to 3018' @ 11:30 AM on 2-26-55. Ran 92 jts of 5 1/2" OD casing set @ 3018' and cemented with 300 sacks cement. Plug down to 2983' @ 8:10 PM, 2-26-55. Maximum pressure of 800#. Ran temperature survey and found top of cement outside of 5-1/2" casing @ 1766' or 69.6% fill. After W.O.C. for 24 hours tested 5 1/2" OD casing for 1/2 hr. before drilling plug and cement with 1000# - no pressure drop. Drilled cement from 2983' to 3018' and tested 5 1/2" casing with 1000# for 1/2 hour - no pressure drop. Continued fifth completion operations.
