FULL DETAILS OF PROPOSED PLAN OF WORK

Propose to plug and abandon well as follows:

1. Spot 10 sacks cement at 3035' (total depth).
2. Fill casing with a heavy mud laden fluid.
3. Shoot off casing at 2500' and pull.
4. Spot 10 sacks cement at 2270'.
5. Spot 10 sacks cement at 1500'.
6. Spot 10 sacks cement at 308'.
7. Spot 10 sacks cement at surface.
8. Erect a 4" x 4' pipe marker.
