DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

200' Red Bed. Finished drilling 12-1/4" hole @ 5:00 PM on 1-24-55. Ran 6 jts of 8-5/8" OD casing set @ 194' and cemented with 100 sacks cement. Plug down to 180' @ 8:00 PM on 1-24-55. Maximum pump pressure of 300#. Cement circulated estimated 5 sacks cement. After W.O.C. for 12 hours tested 8-5/8" OD casing with 1000# pressure for 1/2 hour - no pressure drop. Drilled cement from 173' to 200' and tested 8-5/8" OD casing with 1000# pressure for 1/2 hour with no pressure drop. Started drilling 7-7/8" hole @ 1:30 PM on 1-25-55
