(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pump 50 sack cement plug to T.D. using 10# mud to pump plug. Plug interval 2900-3023 TD. Bottom of 5 1/2" casing is 3014'.
2. Pressure test plug.
3. Cut off and pull recoverable casing.
4. Fill hole with 10# mud.
5. Bottom of 8 5/8" casing is 293'. Set 25 sack plug from 265-315 feet.
6. Put 5 sack cement plug and pipe marker in top of surface pipe.
