Gentlemen:

Reference is made to your letter of July 26, 1961, wherein you request administrative approval of certain changes in your water injection well pattern, North Caprock Queen Unit, Lea County, New Mexico. If administrative approval cannot be granted, you request a hearing on the matter.

It is our understanding that because well no. 31-2 apparently has sustained a casing rupture and cannot effectively be used as a water injection well, you wish to substitute well no. 31-3, one location to the west, as an injector. Due to porosity and permeability conditions to the west and to the north, you do not anticipate a decrease in the efficiency of the flood.

Inasmuch as these wells are both within the North Caprock Unit Area and do not offset producing properties owned by any other party, and since this modification does not, in our opinion, constitute any substantive change in the original plans for flooding this area, we see no necessity for a hearing of the matter.

Administrative approval is, therefore, granted for the substitution of Unit Well No. 31-3, located in the NE/4 NW/4 of Section 31, Township 12 South, Range 32 East, as a water injection well in place of Unit Well No. 31-2, located in the NW/4 NE/4 of said section 31.
