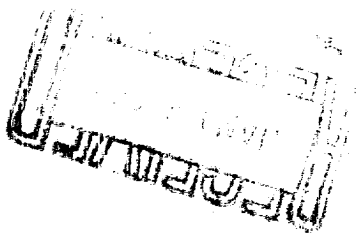

Cable tools moved in 12-27-49. Started to clean out and drilling. Drilled to total depth of 3033. Shot with 60 lbs. O.W.F. from 3007 to 3033. Tamped with pea gravel from 2995 to 3007. Dumped 6 sacks cal-seal from 2865 to 2995. Filled hole with oil. Shot at 8:00 A.M. 1-2-50. Drilled cal-seal and cleaned out to total depth of 3033. Swab test showed 95 bbls. oil first 24 hours.
