Cut & pulled 3 1/2" casing at 10,351'. Ran 4 1/2" 11.6# casing and set at 8873'. Cemented with 265 sacks Incor-Pozmix, 2% gel & 8# salt. Top cement 8010'. PBTD 8831'. WOC 48 hours. Tested pipe to 4000 psi for 30 minutes, held o.k. Spotted 750 gallons mud acid & perforated 12- 3/8" holes at 8718, 8730, 8738, 8752, 8762, 8774, 8780, 8792, 8804, 8806, 8808 and 8815. Let acid soak overnight. Prep to break down and swab test.
