J. T. Caudle No. 7-C, 3-12-33, Bagley Upper Pennsylvanian Gas Pool—all forms required by DC Order No. 501 with the exception of Forms C-104 and C-110. If the acreage to be dedicated is other than 320 acres, it will be necessary to obtain a Non-Standard Proration Unit Order.

Further, please file Form C-128 for the Shell Amerada State A Unit No. 1 in Unit P of Section 33, T-11-S, R-33-E. The plat presently on file is an old one which makes the statement "Under consideration for unitization".
