Tested casing & connections with 1100# for 1/2 hour - No pressure drop. Drilled cement from 3723' to 3790' & tested casing and connections with 1100# for 1/2 hour - No pressure drop. Started drilling formation and 7-7/8" hole at 2:45 P.M., 2-20-51.**
