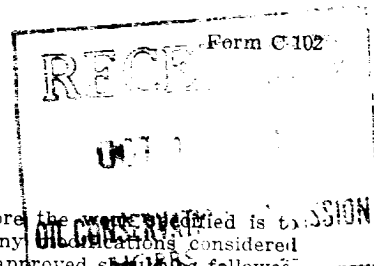

Casing set @ 11040' with 600 sacks Slow-set Cement mixed 3% Jel and 1/4" Flo-Seal per sack. Plug to 10951' @ 9 PM, 10/16/51. Maximum pump pressure, 1750#. Ran 10 Baker Centralizers spaced 30' apart from 8968' to 9058, from 9760' to 9850' and from 11000' to 11030'. Ran 20 Weatherford Scratchers spaced 15' apart in the above sections. After W.O.C. for approximately 24 hours we will test casing shut-off.
