9400' Total Depth - Lime. Ran Temperature Survey - top of cement outside of 5½" casing at 6700', ratio of actual to calculated fill, 59.8% fill. Ran 2-3/8" OD Tbg. W/4-3/4" bit & checked top of cement at 9309' Tested casing and connections with 1000# for 1/2 hour - no pressure drop. Drilled cement from 9309' to 9390' and tested casing for 1/2 hour with 1000# - no pressure drop. Continued with completion operations.
