9417' T.D. 9412' - Line. Finished drilling 7-7/8" hole @ 7:15 PM, 10/30/52. Ran Schlumberger's Surveys. Ran a total of 257 Jts of 257 Jts of 5-1/2" casing set @ 9417' with 600 sx cement. Plug pumped to 9329' at 9:31 AM, 11/1/52. Max pressure, 1800#. Ran temperature survey - top of cement outside 5 1/2" casing @ 6561', or 64.2% Fill. After WOC for 24 hours, drilled cement from 9329' to 9412'. Tested casing w/1200# for 1/2 hour before and after drilling cement - No pressure drop. Continued with completion operations -
