Well shut in. This well produced until April 1973 when its proration acreage was assigned to our State "D" Alc 1 No. 1 to gain advantage of higher structural position. The State "D" Alc 1 No. 1 was originally drilled on 40 acre spacing, but had never produced since the field rules adopted specified 80 acre spacing. We plan to leave this well idle for future use in the event of mechanical problems with State "D" Alc 1 No. 1.
