Well shut in. This well was drilled to the Devonian on 40 acre spacing in 1952, but was never produced since field rules adopted specified 80 acre spacing. Well was completed as Penn producer in July 1970 and was TA'd in October 1971 due to uneconomical producing rate. Acreage is currently assigned to our Amerada State "BTL". We plan to leave this well shut in for future use as replacement for the "BTL" well in the event of mechanical problems since it offers structural advantage at the Devonian.
