Ran 2-3/8" OD tubing with cement retainer set at 8955'. Squeezed 5-1/2" casing perfs. from 9014' to 9034' and 9254' to 9262' with total 250 sacks 310-set cement. Drilled out to 9010'. Perforated 5-1/2" casing from 8992' to 9002' with 2 shots per foot by Schlumberger Micro log. Acidized perfs. with 1000 gals. GRA acid. Swab tested. Unable to recover lead oil. Closed in and T.A. 3-19-66.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
